1. Community Adjustment Fund Application

The General Manager/Secretary-Treasurer provided a brief update as to the details of the Community Adjustment Fund application and the progress to date regarding the various options being investigated by the Building Committee. The discussion resulted in the following motion.

2. Headquarters Conservation Area

The General Manager/Secretary-Treasurer updated the Board on a proposal by the firm of Valard-NAC Ltd., a company contracted to construct the new hydro line from the Bruce nuclear site to Milton, ON, to locate a construction work camp on a portion of the Headquarters Conservation Area north of the maintenance shops. The land is presently vacant and is adjacent to the area used by the Saugeen Flyers, a remote control airplane club. The area is also close to the proposed site of the Children's Safety Village. It is proposed that the camp will be in place for a period of three years.

THAT the Board of Directors of the Saugeen Valley Conservation Authority agrees in principle to the lease of land at the Headquarters Conservation Area to the firm of Valard-NAC Ltd. and its

THAT staff be directed to continue discussion to establish a suitable lease agreement for presentation to the Board of Directors for final approval.
